Sustainability Strategy

- Implement a science-based target methodology and framework and a decarbonisation plan to Net Zero in line with the island's GHG reduction targets.
- Promote carbon literacy among our employees through appropriate training and information sharing.

Climate Change

- Embed adaptation measures to manage the physical and transitional climate-related risks associated with our business.
- Periodically review our climate change risks and opportunities assessment to ensure that they are still up to date and relevant
- Support climate change and energy awareness initiatives within the company and local community where possible.

Roles & Responsibilities

- Chief Sustainability Officer shall act as a specialist advisor to the Board on sustainability matters and report on group sustainability activities to the IEG Leadership team and in turn quarterly to the IEG Board.
- Head of Risk and Compliance shall investigate ESG incidents and manage ESG risk across the business.
- Sustainability Team engages with our service areas in the delivery of aspects of sustainability matters
- Net Zero Working Group made up of Sustainability Champions that ensure sustainability is embedded in everyday thinking.
- The IEG Leadership Team shall carry out an Annual Management Review of our Sustainability Framework in alignment with ISO14001 guidelines.
